

Some main themes of the seminar include, but are not limited to, the following:


- The effectiveness and efficiency of training programs with new technological applications

#### **GUIDELINES FOR PAPER SUBMISSION**

## Page 1 includes following information:

- Name of author/author group
- Academic title
- Contact information: Address, email and phone number

## The remaining sections include following information:

- Title of paper
- Abstract
- Key words
- Content
- List of references

#### Format:

- MS Word (saved as .docx or .doc); A4 page; Unicode encoding with Times New Roman font; font size 13, top and bottom margin 2cm, left margin 3cm, right margin 1.5cm; line spacing 1,3, space above and below 6pt, left margin is 0.75cm when starting a new paragraph;
- Language: Vietnamese (or English);
- Papers should not exceed 12,000 words, excluding references/appendices and author's information:
- Page number: footer middle;
- Alignment: Justify;

- The article should number all tables. Table title is placed above the table, lowercase, only uppercase the first letter, not bold. Figures, charts, maps, flowcharts, etc... should be placed centered and presented immediately after the content referring to them. Images must be clear and in good quality;
- All images in the article are also numbered, the title name is lowercase, only the first letter is uppercase and not bold;
- Math formulas presented as editable text, do not send formulas as images. Formulas and equations should be numbered consecutively, in brackets, on the right side of the page;
- Referencing style should follow Vancouver standards.
