We welcome experts, researchers, scholars, and practitioners to contribute papers for the conference on, but not limited to, the following points:

(1) The current situation of financial consumer protection in Vietnam (consumer protection; conflict resolution mechanisms; the “black credit” or usury; the information transparency of financial products and services; legal and regulatory frameworks; fintech and its impacts on financial consumers...)

- (2) International experiences and regulatory practices on financial consumer protection; practical implementation in different countries.
- (3) The policy recommendations and solutions to enhance financial consumer protection in Vietnam.

Deadline, structure and format of the paper:

- Deadline: *15th July 2021*
- The length of the paper should be between 4,000 - 6,000 words (not including the list of references) and must include:
 - o Title
 - o Abstract and key words
 - o Content of the paper
 - o List of references
- The paper can be written in Vietnamese or English.
- Times New Roman font, size13, line spacing 1.2, in A4 and Word format (Margin: top 2.5cm, bottom 2.5cm, left 3cm, right 2cm).
