#### **ON THE FAEA**

The Federation of ASEAN Economics Association (FAEA) is a non-governmental organization comprising the economic associations of several Southeast Asian countries. FAEA was established in 1976 with the aim of promoting economic research through scientific exchange, coordination and cooperation among countries in the region.

Currently, FAEA has 7 member associations from Cambodia, Indonesia, Malaysia, Philippines, Singapore, Thailand and Vietnam.

The FAEA actively contributes to the scientific argumentation for economic policymaking in each of its member countries and contributes to the overall economic development of the region. The FAEA does this through regular scientific exchanges and cooperation between its member associations, and in particular through the FAEA's annual conference, which is organized alternately by member associations according to different jointly selected themes. During the conference, ASEAN economists exchanged views, research results, shared economic development experiences of other countries, and proposed ideas on strategies and policies for ASEAN's economic cooperation.

Vietnam Economic Association (VEA) has joined FAEA since 2002. Up to now, VEA has organized 3 FAEA conferences in Hanoi:

- In 2002 the Conference with the theme "Economic globalization: Opportunities and challenges for ASEAN countries".
- In 2008 the Conference with the theme "Agricultural development towards the Southeast Asian economic community".
- In 2015 the Conference with the theme "ASEAN Economic Community: Opportunities and Challenges in the Post-establishment Period".

## **THE 45<sup>th</sup> FAEA CONFERENCE**

The Covid-19 pandemic, which has slowed down economic activities on a global scale, has just shown signs of ending, but intense political conflicts in some regions are putting the world at risk into severe crises in energy, food security, inflation and economic recession. ASEAN countries are facing challenges to recover post-pandemic economic growth and respond to negative fluctuations in trade, investment, labor migration and international cooperation. The political, economic and social environment requires each Southeast Asian country and the ASEAN Community to develop appropriate new strategies and policies.

## **GOALS**

The goals of this conference are to:

- Share research results and experiences on issues arising from the impact of the Covid-19 pandemic and global conflicts on ASEAN countries.
- Exchange views, approaches, methods to assess the impact of global and regional changes on ASEAN economies and seek strategies and solutions to manage change
- Identify areas of cooperation in research and programs among ASEAN economists of mutual interest and benefit.

## **CONFERENCE CONTENT**

According to FAEA practice, the annual Scientific Conference will gather research results on various socio-economic issues related to the development of ASEAN countries and globally.

The focus of the 45<sup>th</sup> Conference is expected to include the following issues:

1. Recovery and economic growth after the Covid-19 pandemic.
2. Energy security, energy restructuring.
3. Food security, nutrition status and agricultural development.
4. Demographic changes and labor migration under the influence of the Covid-19 pandemic.
5. Development investment and trade.
6. Transportation and logistics.
7. Tourism and services.
8. Impact of the Covid-19 pandemic on business activities of enterprises.
9. Enterprises with digital transformation and the application of Technology Revolution 4.0.
10. Finance, currency, inflation, public debt.
11. MDGs and poverty reduction.

12. Comparative analysis of the impact of the Covid-19 pandemic on socio-economic development in countries and localities. Accumulated experience in pandemic response, prevention and control.
13. Cooperation to develop the ASEAN Economic Community.
14. Economic relations of ASEAN with other countries and regions in the world.

## **VENUE AND DATE**

The conference will be held for two days in Hanoi, Vietnam. Date: November 24-25, 2022 (Friday to Saturday).

On the third day, November 26, we plan to organize a tour in the scenic Ninh Binh province, 100km from Hanoi for those who want to have a more enjoyable experience on the occasion of visit to Vietnam.

The conference venue, and hotel information will be announced in October 2022 (Expected stay at 4-star Daewoo Hotel in Hanoi).

- Decision on acceptance of papers: 15 September 2022

• **Guidelines:**

- The cover page of the paper should contain the title, authors' names, affiliations, phone and fax numbers and email addresses.

- The abstract and full papers should be written using Microsoft Word Document with font Times New Roman, font size 12 and 1.5 spacing.

- Footnotes should be numbered consecutively in the text.

- Illustrations, figures and tables should be numbered in Arabic numerals, accompanied by titles and sources.
