

## CALL FOR PAPERS INTERNATIONAL CONFERENCE

### **“Standardization - Connected platform in modern and sustainable agricultural production**

Standardization is an essential requirement for agribusiness in the process of globalization. Producing according to advanced methods and technologies with clear and transparent standards will help Vietnam's agricultural industry to reduce risks, develop sustainably, and be proactive in the face of changes in the natural environment and the world economy. By imposing regulations on technical specialities and management requirements, standardization contributes to improving productivity, quality and efficiency of agricultural production and business, thereby developing the modern and sustainable agriculture and high position in the domestic and world market.

With the goal of creating a forum for sharing and discussion on practical experience in establishing and applying the national standard system in Vietnam and other countries in modern agricultural production, the National Economics University in collaboration with Food and Agriculture Organization of the United Nations (FAO), Korean Valuation Association (KVA), and Ministry of Agriculture and Rural Development will organize an International Conference "**Standardization - Connected platform in modern and sustainable agricultural production**". The contributions of the Conference will help identify problems in the process of establishing and applying the national standard system of Vietnam, especially emphasizing its role as the foundation in modern agricultural production, thereby proposing effective solutions to enhance the role of standardization in the context of international integration and digital transformation.

The National Economics University would like to invite scientists, managers to participate in writing articles for the Conference. The topic of the article focuses on the following specific topics:

1. The role of standardization in high-tech agricultural production in the context of international integration, digital transformation and implementation of sustainable agricultural development goals;
2. Develop standards to create a connected platform for modern agricultural production;
3. The practices in establishing and applying the standard system in agricultural production in Vietnam and other countries;
4. State policy on development of activities in the field of standards and technical regulations in agriculture;
5. Training human resources working in the field of standards and technical regulations of Vietnam and other countries;
6. Vietnam's participation in international and regional standardization activities in the agricultural sector;
7. Opportunities and challenges for Vietnam in strengthening international cooperation in the field of standardization in general and in the agricultural sector in particular;

8. Solutions for establishing and applying the national standard system in the agricultural sector in Vietnam.

Full submitted papers must be in English, with the length of 6000 - 10,000 words (excluding Appendix, List of References), Times New Roman font, font size 13, line spacing 1.3, specifying the author's full name, working place, contact phone number and email address. 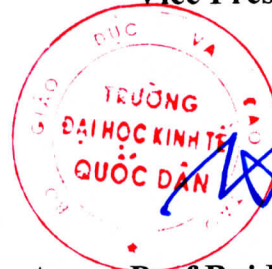
